This is the privacy statement of study association Babylon, established in Nijmegen and registered in the trade register of Kamer van Koophandel, with number 40146352. In this statement you will find information about the personal details of the members and alumni (hereinafter: the members) that Babylon collects and processes. When registering, the Members gave permission for processing their personal data. Babylon does not collect or process any information for purposes other than the purposes described in this statement, unless the members have given permission in advance.

Personal data

Babylon collects personal data from you if you become a member by means of registration via the registration form, or via the website of Babylon. The provided personal data are stored in the member file. This member file is saved on a secure server. Members have the right to end their membership at any time and thus the right to withdraw their consent to the processing of their personal data. The personal data will be then preserved until after the academic year in which the membership is ended. Babylon collects the following personal details of their members:

- First and last names;
- Addresses;
- Email address;
- Telephone number;
- Date of birth;
- Sex;
- Student number;
- Start academic year;
- IBAN.

It is at all-time possible to review and adjust your personal data. For changing your data you will have to contact secretary@svbabylon.nl . To see in your personal data you have to go to the Babylon room (Erasmusbuilding, E12.09).

Photos

During activities of Babylon, photos are taken. The photos that are made will be uploaded onto the website of Babylon. Photos can also be used on the social media of the association. The social medias used by Babylon are: Facebook, Instagram, LinkedIn and twitter. Photos can also be placed in the *Babbel* and the Babylon Magazine. Photos are filtered by the board before they are placed.

Third parties

Active members can have access to personal data if their committee work requires this. With other third parties such as companies, the university and other institutions, the personal data is only shared when it is relevant for the member, and the member has given permission for this.

Reporting obligation for a data breach

If it ever occurs that there is a data breach within Babylon, Babylon will have to notify all members and stakeholders of the situation. A data breach is "the unauthorized movement or disclosure of sensitive information to a party, usually outside the organization, that is not authorized to have or see the information." (NICCS, 2017).
